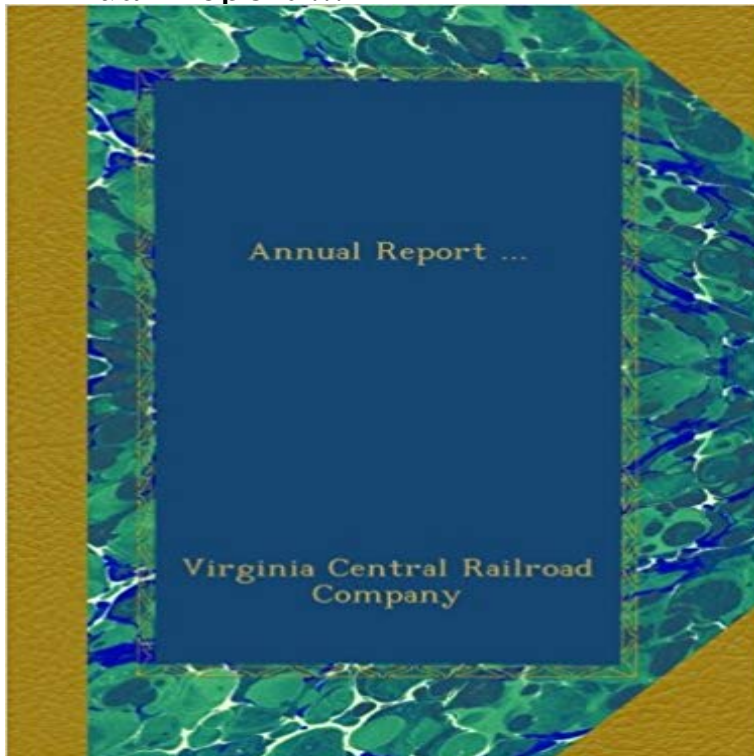


Annual Report ...
